Bdg 47: around 6 000 m3 building housing the investment protection electrical distribution system composed of MV distribution, LV distribution, UPS, chargers and batteries (6 MVAs of electrical power). Supply of electrical equipment excluded.

Supply and installation of more than 5 km of cable trays and 20 km of cables.
