The HEBT AC Current Transformer (ACCT) of LIPAc has been designed, manufactured and tested by the industrial supplier Bergoz Instrumentation under a contract with one of JT-60SA voluntary contributors, CEA. The ACCT represents an ad-hoc system, specifically developed for LIPAc. It is based on the current transformer itself specifically designed and manufactured for this application (taking into account the constraints related to limited space between the 2 quadrupoles where it is installed) and a commercial amplifier customized by Bergoz for the needs of this application.

As the scope of this contract is to replace the broken HEBT ACCT developed for LIPAc by Bergoz Instrumentation, it must be procured by Bergoz in order to ensure compliance with the LIPAc application.
