International courier and parcel services including shipments from or to the F4E offices in Barcelona to any destination in the EU, Europe, or worldwide, as well as shipments between international locations that do not pass through Barcelona.

Indicative selection criteria (only the final selection criteria indicated in the Invitation to tender will be taken into account for the selection of successful tenderers):	Successful candidates shall: <ol style="list-style-type: none">1) have an average consolidated turnover for the last 2 (two) financial years for which accounts have been closed equal or larger than EUR 70 000;2) Demonstrate at least three years of relevant experience in activities comparable in scope and complexity to the contract requirements, proven by a minimum of three contracts—either ongoing or completed—prior to the tender submission deadline.
