<b>Title of the procedure:</b>	<b>Provision of Medical Centre Services to Fusion for Energy in Barcelona</b>
<b>Scope of the procurement:</b>	<p>F4E aims at signing a Contract to procure the services of a Medical Centre consisting mainly of:</p> <ul style="list-style-type: none"> <li>- Pre-Recruitment Medical Examinations of job applicants to be employed by the Contracting Authority, consisting of laboratory tests and exams with the aim to support the Medical Advisor's decision as to whether a job applicant is fit for work;</li> <li>- Preventive Annual Medical Check-Ups for the Contracting Authority staff members by applying a respective programme depending on their gender, age, the clinical history and on the risks related to the job:</li> </ul> <p>The Medical Centre shall be understood as a clinic of medical assistance providing services of integrated medical occupational health to Fusion for Energy.</p>
<b>Budget:</b>	The maximum ceiling amount for this Contract is < 140 KEUR
<b>Activity code or CPV:</b>	85100000
<b>Technical documents for information:</b>	The tender documents will be sent to pre-selected candidates and all the interested candidates who have expressed their interest.
<b>Minimum number of Candidates to be invited</b>	A minimum of 5 candidates will be invited to submit a proposal. Only candidates from F4E Member States <sup>1</sup> will be invited.

<b>Indicative selection criteria (only the final selection criteria indicated in the Invitation to tender will be taken into account for the selection of successful tenderers):</b>	<p>Successful candidates shall:</p> <ol style="list-style-type: none"> <li>1) have an average consolidated turnover for the last 2 (two) financial years equal or larger than EUR 70 000 (seventy thousand);</li> <li>2) be located within 20 (twenty) Km from Fusion for Energy premises and have to be reachable by public transport.</li> </ol>

	<p>3) The Medical Centre(s), facilities and medical equipment shall allow it to perform the services as described in these Tender Specifications. This encompasses at least:</p> <ul style="list-style-type: none"> <li>- reception desk, waiting areas, doctor's offices, etc.,</li> <li>- Medical equipment which allows the provision the medical services under the Contract.</li> </ul> <p>4) At least 1 (one) Radiologist, 1 (one) Ophthalmologist and 1 (one) Gynaecologist with at least 3 (three) years of experience in their domain.</p>
